RE: Overtime Call Order Clarification

George,

Below is the clarification of the Overtime Call Order for both the Track and B&B Departments in the event one Department needs support from the other. I realize that we discussed this topic briefly approximately a year ago and that I would put out a letter of explanation. I apologize for taking so long in doing so, but with this recent storm this issue has been raised again, so to avoid any future confusion can you distribute this letter of explanation to all Managers, Supervisors and Assistant Supervisors.

On page 2 of both the Track Department and the B&B Department, the Overtime Call Order states the following:

**Track Dept.:**

**After the Call Order has exhausted all Track Department Employees, (*qualifications being sufficient*) working in class/out of class within a Subdivision and its 1<sup>st</sup> adjacent Subdivision, during severe/extreme weather conditions the Call Order may use the senior qualified Track Rostered, B&B Department Employee headquartered within the Subdivision where the call originated. This applies to all categories listed in this Call Order.**

**EXAMPLE: The Call Order exhausts all of the qualified Track Dept. Employees headquartered within the New Haven Sub-Division: The Call Order must then exhaust all of the Track Dept. Employees (*qualifications being sufficient*) in the Midway Sub-Division, before affording the work to the Track Rostered, B&B Dept. Employees headquartered in the New Haven Sub-Division.**

**B&B Dept.:**

After the Call Order has exhausted all B&B Department Employees, *(qualifications being sufficient)* working in class/out of class within a Subdivision and It's 1<sup>st</sup> adjacent Subdivision, *during severe/extreme weather conditions* the Call Order may use the senior qualified B&B rostered, Track Department Employees headquartered within the Subdivision where the call originated. This applies to all categories listed in this Call Order.

**EXAMPLE:** The call Order exhausts all of the qualified B&B Dept. Employees headquartered within the Boston Sub-Division: The Call Order must then exhaust all of the B&B Dept. Employees *(qualifications being sufficient)* in the Providence Sub-Division, before affording the work to the B&B rostered, Track Dept. Employees headquartered in the Boston Sub-Division.

The Italicized/underlined text has been added in an effort to keep employees from driving great distances during severe/extreme weather conditions, the intent is to only implement the provision in the event of severe/extreme weather conditions.

At all other times *(when no severe/extreme weather conditions are found to exist or forecasted)* the respective department's Overtime Call Order is to be followed as outlined, with calls being placed to the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> adjacent subdivisions if necessary. In the event that all adjacent Subdivisions have been exhausted for a particular Department, said department will afford the work to the Senior Rostered Qualified Employee working in the opposite department within the subdivision where the call originated.

**Simply stated:** If the B&B DEPT needs support, and all of the adjacent subdivisions have been exhausted, the work will be afforded to the Senior Rostered B&B Qualified, Track Dept. Employee, headquartered and working within the subdivision where the call originated. The same applies if the Track Dept. needs support from the B&B Dept.

- Second Call Senior qualified Secondary I&R Foreman working in class headquartered within the Sub-Division
- Third Call Senior qualified Foreman/Assistant Foreman working in class, headquartered within the Sub-Division. *i.e.; Lubricator, Crane, Welding, Maintenance Foreman, etc.*
- Fourth Call Senior qualified rostered Foreman not working in class, headquartered within the Sub-Division.
- Fifth Call Senior qualified Production Foreman/Assistant Foreman working in class headquartered by existing bulletin within the Sub-Division.
- Sixth Call Senior qualified rostered Foreman/Assistant Foreman (Production) not working in class headquartered by existing bulletin within the Sub-Division.
- Seventh Call Adjacent Sub-Division; Starting with First Call

**Category I – Maintenance Track Foreman**

**Foreman with sufficient qualifications working in class**

- First Call      Senior qualified Maintenance Foreman working in class headquartered within the Sub-Division
- Second Call    Senior qualified Foreman/Assistant Foreman working in class, headquartered within the Sub-Division. *i.e.; Lubricator, Crane, I&R, Welding Foreman, etc.*
- Third Call      Senior qualified rostered Foreman not working in class, headquartered within the Sub-Division.
- Forth Call      Senior qualified Production Foreman/Assistant Foreman working in class headquartered by existing bulletin within the Sub-Division.
- Fifth Call      Senior qualified rostered Foreman (Production) not working in class, headquartered by existing bulletin within the Sub-Division.
- Sixth Call      Adjacent Sub-Division; Starting with First call.

*All rules referenced in this call order refer to the current agreement.*

**In the Second and Forth call Assistant Foreman working in class will be upgraded to Foreman before moving onto the *Rostered Foreman not working in class* call. This applies to all Foreman categories listed in this call.**

**Before going to an adjacent Subdivision, the Call must exhaust all rostered employees' qualifications being sufficient, headquartered within the Subdivision. The term "rostered employee" denotes any employee who has acquired rights on a specific roster in accordance with Rule # 3 part (e). Any employee who has not acquired roster rights on a specific roster may be upgraded to that position (*qualifications being sufficient*) on overtime; only after all other qualified rostered employees (*of that Subdivision and the first adjacent Subdivision*) of that position have been afforded the opportunity to work. An employee covering a position in accordance with Rule # 4 will be entitled to all overtime associated with that position, regardless of their "rostered employee" status. This applies to all categories listed in this Call Order.**

**EXAMPLE:** If any type of Gang is headquartered in Sub-Division # 2, but is working in Sub-Division # 3, any support that gang needs, will be offered to the senior qualified employees' working in class/out of class headquartered in the subdivision where the work is being performed. (*In this example, the Call would go to the employees headquartered in Sub-Division # 3*) This applies to all Subdivisions and categories listed in this Call Order.

After the Call Order has exhausted all Track Department Employees, (*qualifications being sufficient*) working in class/out of class within a Subdivision and its 1<sup>st</sup> adjacent Subdivision, the Call Order may use the senior qualified Track Rostered, B&B Department Employee headquartered within the Subdivision where the call originated. This applies to all categories listed in this Call Order.

**EXAMPLE:** The Call Order exhausts all of the qualified Track Dept Employees headquartered within the New Haven Sub-Division: The Call Order must then exhaust all of the Track Dept Employees (*qualifications being sufficient*) in the Midway Sub-Division, before affording the work to the Track Rostered, B&B Dept Employees headquartered in the New Haven Sub-Division.

The position of Safety Liaison will be included (*qualifications being sufficient*) when the Call Order reaches the "Production not working in class" category within the subdivision the Position is headquartered in

**Category II - I&R Calls**

**Work that is ordinarily and customarily performed by the B&B Department but is contracted out and requires protection; That protection will be provided by qualified B&B employees; If said protection requires Track out of service, On Track Equipment, piloting of On Track Equipment or has the potential to disturb the track structure, then a Track Foreman will provide the protection/piloting.**

**In the event that another Department(C&S, ET, etc.) requires support for protection/piloting, that support will be provided by qualified Track Department Employees, headquartered in the subdivision where the work is being performed. Referencing the Call Order for preference.**



**Category IV. - EWE Operators and Truck Drivers**  
**EWE Operators and Truck Drivers with sufficient qualifications**

First Call	Senior qualified EWE working in class headquartered within the Sub-Division
Second Call	Senior qualified rostered EWE not working in class, headquartered within the Sub-Division

**Example for First Call**

**If there is more than one EWE position headquartered in a gang or a subdivision, (i.e. Backhoe, Speed Swing, Loader, etc.) and the over-time assignment in that subdivision requires the use of only one piece of equipment; Or a piece of equipment is used to support another department (C&S, ET, B&B, etc.) then the Senior Employee assigned by bulletin to the equipment will get the call.**

**If a bulletin assigned piece of equipment from one subdivision is needed on another subdivision, the assigned employee will not travel with the equipment, unless the assigned employee is the only qualified operator of said equipment.**

Any employee who has not acquired roster rights on a specific roster may be upgraded to that position (*qualifications being sufficient*) on overtime only after all other qualified rostered employees (*of that Subdivision and the first adjacent Subdivision*) of that position, have been afforded the opportunity to work. An employee covering a position in accordance with Rule # 4 will be entitled to all overtime associated with that position, regardless of their “rostered employee” status. This applies to all categories listed in this Call Order.**
